WORLD CIVILIZATION FROM NOAH

GENESIS

The Bible and the Mexican Codices both offer accounts of the creation of the world. In our book, we diverge from the typical starting point and instead focus on the last world reset – the global flood, which many nations and scientists believe occurred around 5 thousand years ago. Within this cataclysmic event, one man and his family, Noah, his wife, and his three sons, played pivotal roles in repopulating the world. The reason for God’s choice of Noah’s family was their genetic purity, unlike the rest of the world, where genetic corruption had spread to animals, people, and plants.

Noah’s three sons were Shem, Ham, and Japheth. Ham’s wife bore two daughters, both with six fingers, similar to the Nephilim. Ham also had a son named Canaan, born during the deluge, which challenges the traditional 40-day storm timeline and raises questions about the story’s consistency and chronology. Starting from World War 1, 1918-1940, world technology was unleashed at an exponential rate. We went from a mechanics phase and understanding electricity to the most incomprehensible form of "magic" that allows men to use metaphysical communication to animate dead material like your computer.

Right at that time (WW1), an imbalance took place after the sacrifice of so many people; the programming of energy through auditory and visual frequency manipulation was created. This magical imbalance had to be adjusted; so in 1970, the discovery of the Dead Sea Scrolls rebalanced the narrative. These writings reaffirm the spiritual interface with dead elements, where it came from, its evolution and ultimate goal. "Nothing is new under the sun"

There are 225 **copies** of manuscripts dated projected date between 150BC and year 70AC based around the destruction of Jerusalem by Emperor Titus and General Vespasian. 69 books or ~900 documents of 50K pieces were put together reaffirming the 3 books that were omitted from the Old Testament at the assembly of Nicea. These books are the books of Jasher, Jubilee and the book of Enoch. They are other books suppressed by the Vatican. The 66 salvaged scrolls were fundamentally adopted as tools to validate the new age Bible. The most popular Christian Bible, like Kings James and Louis Second version originates from the "Hebrew Masoretic", the Jewish translated & modified version. However, three out of the earlier translations differ on the timeline events and other things. It is so inconsistent that it has created numerous interpretations, or referral sources for religions... Most people are fanatics and never questioned its originality or legitimacy. Nowadays, we have the Internet, which helps compare and access a lot of bible information. The question remains, how would one discern the real facts from these books.

Registering historical events started right at the time of Enoch, which is the 4th generation from Adam. Many historical civilizations can recall close to 4-5K years of recorded history. From Noah, Shem, Heber through the patriarchs Moshe, Abraham and Jacob, has a particular covenant with Yahawah. Heber called his people the Hebrews and Jacob's Israel. This lineage's popularity is due to the action and success of Yahawah to the other worship gods. All of these people recorded important events pertaining to their history and covenant that makes the Israel Nation the most powerful people under God.

CRITICAL TIMELINE JUSTIFICATION

Is it considered a discrepancy when the Hebrew Masoretic translation indicates that Shem outlived his entire family? This could have resulted in significant emotional distress. In all other translations, each father from Shem to Abraham passed away before their children, by adding an extra 100 years to their ages, as seen in prior translations. This approach seems to follow a more conventional and natural pattern of succession.

There are numerous inconsistencies, not limited to the timeline, which adds approximately 1000 years to our current chronology. These inconsistencies also encompass the number of people migrating from one location to another, the locations of significant events, and even the names of God. We are uncovering hidden information, such as evidence of Americans speaking Hebrew. Additionally, documents are coming to light that reveal the presence of Phoenicians and Moors in the Americas before the Inquisition. These findings have been held within institutions like the Smithsonian Library, along with indications of the influence of Constantine and Viking art in America.

They point to the existence of an intricate Hebraic geometric community, concealed buildings, and landscapes controlled by the government, with engineering constructions resembling the Pyramid of Giza throughout the entire Americas. All of these discoveries present a narrative that challenges the notion that indigenous Americans required “cleansing” by the supposedly more civilized Europeans.

FIRST “THE ORIGINS OF AMERICA”

First, let’s analyze the name America and its meaning. Then, we should be able to compare if this name is mentioned in the bible. If the Bible is about our entire world civilizations, then we should be able to have references that include all parts of the world and their development. In there we should be able to have the origins of the mongoloid, Arabs, Asiatic, Europeans, Dark Race and the Negros.

So let's get to it.

THE WRITTEN HISTORY OF THE AMARAKA³

“Amarakan” is the name of “The old world,” which has been rediscovered in European literature as the New World: “Turtle Island” was being “discovered.” This is the place where ancient cities are much older and more complex than any other parts of the world. It is also the place where city wall constructions are so intricate but matches the pyramids style construction. As a fact, even until now it is impossible to reproduce these monuments with our technologies and yet people still believe in evolution. Being practical, adaptation is what we can see and understand. Critical thinking forces us to ask:

AMERICA OR AMAROU KA⁴, ITS DECEPTION AND ETIOLOGY CLARIFIED.

Western historians often credit Amerigo Vespucci, the Florentine mariner originally named Alberico Vespucci, with the naming of America in 1499. This assertion was made public in a famous letter by Bishop Florentine and was further supported by the German cartographer Martin Waldseemüller in April 1507, which was a step toward promoting the idea of a heliocentric globe or a round Earth. Interestingly, it was only after this period that Vespucci began signing his name as Amerigo. Contrary to this claim, it has

long been known that the inhabitants of South and Central America were already using the name "Amarouka."

However, the etymology of "Alberico" is derived from "Albert." It's a common practice for people to use their last names to mark their discoveries. Nevertheless, we can associate the term "America" with the group of aborigines living in the Montagne Range Amerrique and their tribe called the Amerriquan in Nicaragua, disregarding Amerigo Vespucci as the sole originator of the name "America."

- Upon finding the origin of the name and meaning of the land, we realized the similarity of the origin of the word "Egypt." Egypt⁵ was called by its People "Tamen or Tameri" (beloved land) and "Aeria" dark dirt, also other name exist like "Ta-Akht" (fertile soil or "Kmt" (black Soil). The Term TA-Merâu is express to be the people of the land of the Nile-flood, ie the Egyptians.

*These statements indicate that the term "America" has historically been associated with Ancient Egypt, making its biblical reference plausible. In the scientific community, some of the oldest sedimentary rocks have been discovered in the Laurentian Mountains in Canada, suggesting that the Americas are among the oldest continents to emerge after the flood. While it's important to note that carbon-14 or argon dating of rocks can be inaccurate due to the challenge of precisely determining when these elements were first energized, we will consider this relevance for the sake of reference.


SECOND, HOW RELEVANT IS HAITI?

THE MIGRATION AND ORIGINS

The name of a tribe is extremely important. It can define a region but moreover it most likely describes the father or leader of that tribe, Hayiti is one of these islands. It had its aborigine name modify by the colon from (Iti_Ah or Iti_Ya) to Hispaniola. Given the name of Hispaniola for 400 years, Jean Jacques Dessalines formally changed it back to HAYITI.

Christopher Columbus' translator, Luis Torres born *Yosef ben HaLevi Halvri* (Jewish)/Yiddish (Jewish/Hebrew) an Aramaic speaker, wrote a book mentioning the Indians of Haiti spoke an old form of Hebrew. In context if the name of the island was written in Hebrew then because it's a compound name (combined two words) the Europeans would have had to write it from right to left giving you the name of (Ha-iti). The word Iti-(Ya or Ah) in the Hebrew dictionary is defined as (God is with You) but

when taken under consideration that Emmanuel also means (God is with you) there were issues with the real meaning of these names. The indigenous Hebrew name spelled in pictograph  Or "YTI-AH⁶. However, if you conjugate the verb TO BE in Hebrew the first person of this verb which is I AM is written Hayiti. While doing research on the Hebrew language, I realized that words would have multiple meanings.* so broken down the name became clear. Iti means earth or land and Ya or Ah represent God. So putting them together, the significance was apparent: God's Land so the term Haitian should mean God's people. It goes the same way for Emmanuel where (Em) means inside, (man) is man and (el) is also God same as Ya or Ah. Together it gives you "God is within this man."

Today, there are various attempts to decipher the meaning of the name "America," although many have faced challenges in doing so, as evidenced by writings from the Smithsonian Institute. The new inhabitants of Mexico, the Aztecs, tell stories of a peaceful people who were responsible for constructing many of the region's grand cities. The Aztecs, of Mongoloid origin, trace their heritage back to Asia, specifically under the leadership of Genghis Khan's army.

The Incan and Mayan codices describe the Carib people known as "Cakchiquels," who spoke of their great leader, Mesi, whose name has become a part of the land: Mexico. During a significant migration, four priests carried their idol, Vitzilipuzli, in an arc. Vitzilipuzli promised to make them rulers of nations. Originating from the land of Judah, specifically Utah, they migrated south and settled in what is now Mexico. Some of the group continued their journey and eventually reached the Peruvian Mountains.

The Olmec people, known as the great warriors of Aztlan or Saladoides, were originally from the Caribbean, born from the union of two nations: the warrior lineage of Queen Califa of California and King Solomon, the son of Prester John, the King of the Seven Indies. The Olmec's primary goal was to obtain the Ark of the Covenant and construct a new temple for it. Many of their depicted statues have been left behind, providing valuable insights into the characteristics and identity of these people, notably seen in the "Olmec Heads of Peru.

THE 2 TYPES OF PEOPLE IN THE NEW ISLAND

The Islanders were divided into 2 kinds of people: The Arawaks who are the Olmec and the Tainos the mongoloid people who came along and are featured to be the Islands' Indians by the European. The Spaniard created a vast emphasis that the entire islands were Taino's speaking tribes. However, Luis Del Toro, Christopher Columbus Translator, identified the island of Haiti's language as kind of an "older" form of Hebrew, with Paleo Hebrew writings describing the people as dark copper color and beautiful people.

There, the warrior's tribes known as the Maroons protected the queen of the island Anacaona or historically known as (ANA AKHAN) of Leogane. The title "the land is Kiskeya Boyo" in the *English-Haitian Creole Bilingual Dictionary* is reduced to "Haiti love," however its meaning is set to be "The Mother of all Lands or Chef of all Lands." The People of Haiti were the Casique (the leaders (Kasin) a Hebrew term, of all the other islands. In time, the Spaniard, French and English invaders mobilized the North, Central and South American Indians to start the indentured servitude process, which in time the term "slavery" became the norm reference. Haiti and Cuba became the hub to separate families and allocate them to different plantations as human resources. 500 tribes were brought into the island and just after a year with the Roman invaders Haiti started to fight back. It took 400 years after defeating the French, Spaniard and the English to be recognized Sovereign. In time the history book tried to portray the people called today Slaves were imported from Africa. However today we can look into congressional reports and look into the commercial recorded transaction that the number of Africans brought to the Americas were not in such great numbers. Most of the African slaves transited through Europe, mostly France as Haiti was concerned.

THE CONFUSION BEHIND REFERENCE

So far, the term Indigenous people is where the name India comes from. The school's history book defines the reason for the trip of Columbus as a commercial transaction to acquire spice from "india." However, what history fails to mention is the term INDIA was not allocated to the land we recognize as positioned on the subcontinent in south-west **Asia**. However the land of **Bharat** was the name, there its people, who lived near the Indus River, were called the Shindhu people. I always wondered why would the English invade today's India? Was it not as commercially beneficial as the Chinese Opium Market? Maybe the Gold and the work force was incentive enough? After their arrival in the 1700, the name India became officially the name of the country when the English departed in 1947.

THE INTENDED REFERENCE⁷

In the Latin language of ecclesiastics and royalty of the time, [the] “People or Children Of God”, as Spaniards often referred to the Indigenous, translates freely as “Los Ninos’ de la Endeo” and consequently, Los Ninos de la Indios” [more-literally “children of God”]; “En de o” [freely] “of God.

In the Spanish expression “En de o/of God & Los Ninos-the children,” the Latin term “children of God” was “freely” translated in the contemporary Latin language of the time. The feminine form was “la ninias de la endeo,” and the masculine form was “Los Ninos de la Endeo,” both referring to “children of God.” However, over time, this term underwent linguistic transformations. It was initially altered by the Spanish language into “los nineos de la Indio,” and eventually evolved into “Indio.” This term later extended to “Indianer” and “Indian,” ultimately reaching contemporary usage.

This linguistic evolution appears to stem from accounts of Bartholomé de las Casas and additional reports regarding his appeals to the King and Queen of Spain on behalf of the few surviving indigenous people in the Caribbean. These historical narratives provide a valuable perspective on the origin and transformation of the terms “Indio” and “Indian” as applied to the indigenous peoples of the Americas.

THE OUTSIDE ENLIGHTENMENT

1. THE MAROONS

Today, as far as the Maroons, they still exist throughout the Caribbean Islands but predominantly recognized in the Bleu mountain of Jamaica. In August of 2017, on a trip from Ocho Rios to Kingston, my family and I stopped in a little village where Bob Marley was born on the Blue Mountain. There, I encountered an old man who surprisingly taught me a lesson which I will never forget. He introduced me to a misconception about the Maroons; in Haiti the Maroons are considered people who left the city to hide in the mountains. However, this man was telling me that the Maroons were a tribe of hunter-gatherers and mostly skilled in combat who knew the land very well. The old man told me that the Maroons in Jamaica were highly spiritual and did not mingle the non-sense of the world, so they stayed isolated higher up in the mountains in order to stay closer to the God they called Yah. I had so many questions and his answers were so shocking... First, he told me the Maroon called Dutty Bookman (*he gave me another name but I can't recall*) was sent to Haiti to awaken the people spiritually for a decisive and final fight against the invaders. In Arthur Koestler's book "The 13th Tribe," he suggests that modern-day Jews have a historical connection to the Khazar Empire, which existed in the Caucasus and the Volga region of Eastern Europe from the 7th to the 10th century. According to Koestler, the Khazars learned Hebrew from the Canaanite descendants, the Phoenicians, and adopted Jewish practices, becoming masters of the Hebrew language. This empire played a significant role in shaping medieval Europe and had a hand in financial matters by serving as intermediaries and neutral parties in contracts. THE MOORISH INTENT

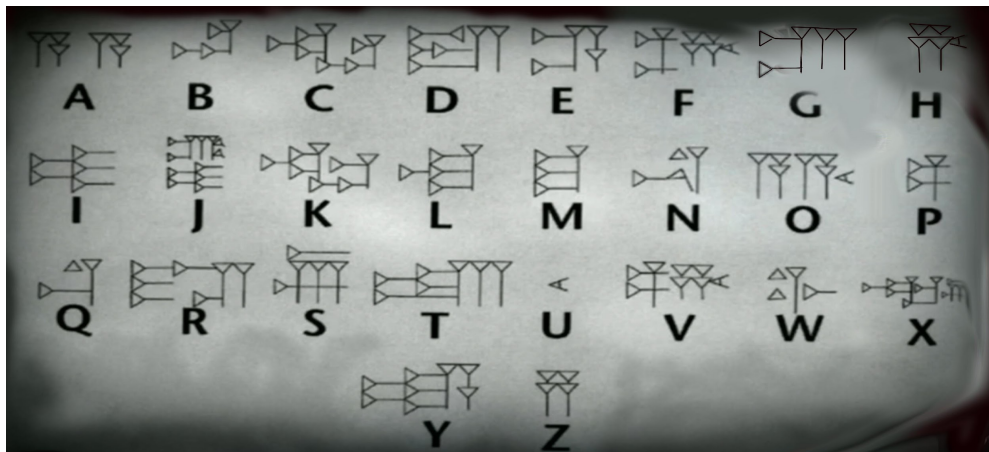

THE ALPHABETS ORIGINATION AND DEVELOPMENT

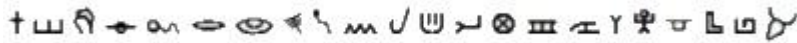
THE START POINT

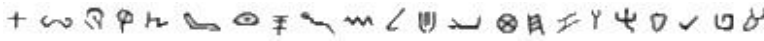

PHOENICIAN AND HAZARIAN JEW LETTERS EVOLUTION

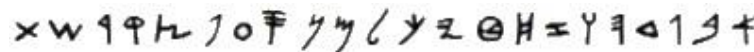


Early Semitic "**Ancient Hebrew**" font

This is the original pictographic script used by all Semitic peoples, including the Hebrews, prior to 1200 BCE.



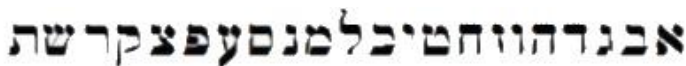

In 1780, John Adams proposed to Congress that English is to be made the Official Language but it was denied and deemed undemocratic. DOCTRINE OF DISCOVERY

The discovery doctrine or doctrine of discovery is a concept of public international law expounded by the United States Supreme Court in a series of decisions, most notably *Johnson v. M'Intosh* in 1823. Chief Justice John Marshall explained and applied the way that colonial powers laid claim to lands belonging to foreign sovereign nations during the Age of Discovery. Under it, title to lands lay with the government whose subjects traveled to and occupied a territory whose inhabitants were not subjects of a European Christian monarch. The doctrine has been primarily used to support decisions invalidating or ignoring aboriginal possession of land in favor of colonial or postcolonial governments.¹⁴

This topic decision has been the subject of a number of law review articles and has come under increased scrutiny by modern legal theorists.

WITH OR WITHOUT YOUR CONSENT

Under the same principle, one would wonder how could your children be taken away from you if the state decides that you are an unfit parent. Who gives authority and or how is it obtained? Well, one has to release his or her rights to the state in order for it to take action. Unknowingly, when the birth of the child occurs you signed a unilateral contract through the filling of the birth certificate to the states giving the state oversight to you child. What seems to be a simple acknowledgement of birth recording becomes a source of commercial endeavor under a bonded document, which is the birth certificate. In it, it is speculated that at the age of 18 the child can claim his independence formally because they have reached the age of reason. No one has ever done it, as it is assumed. However, it becomes apparent that the court system concedes anyone as the ward of the court unless he or she defines his statue. Those who seem to be aware of these technicalities are the wealthy, the lawyers, law enforcers and politicians or people avid to understand the system in order to avoid being a victim.

MARITIME LAWS

Acknowledging Rhodes as the birthplace of **maritime** jurisprudence, the **maritime** code of the later Eastern Empire, dating from the 7th or 8th century ad, was called the "Rhodian Sea **Law**."

Maritime law, also known as **admiralty law**, is a body of **laws**, conventions, and treaties that govern private **maritime** business and other nautical matters, such as shipping or offenses occurring on open water. International rules, governing the use of the oceans and seas, are known as the **Law** of the Sea.

The Maritime Law Ordinances, gathered together in one code the entire criminal, private, procedural, and public laws relating to the sea. Although the French Admiralty Court failed to survive the Revolution that began in 1789, the substantive law embodied in the Ordinances was very closely followed in the *Code de Commerce*, whose adoption in 1807 meant that the maritime law was thereafter considered simply as a branch of commercial law, with consequent diminution of the weight previously given to custom and usage. Furthermore, abolition of the Admiralty Court resulted in the trial of maritime cases by the commercial courts, on which, in the smaller ports, maritime interests might not be represented. In countries with codes based directly or indirectly on the French commercial code, civil maritime cases, as well as non-maritime commercial disputes, are heard and decided by commercial courts.

Why should we understand these laws? Well, when everyone's births are classified under the same perspective ei: taking out of a Canal, you are considered to be a delivered vessel which identifies your jurisdiction to be under the Maritime law, according to the Papistry.¹⁵ Yes, again it's a religious unilateral law that one has to vindicate by claiming your natural birthright so you do not fall victim of the Commercial Codex. Be aware the Island of Haiti still uses a no longer-used as legal law deriving from the maritime laws left by the French, which conclusively creates a judicial cancer in the jurisdiction of the sovereignty of the people. Also, to pronounce another confusion called the Trinity of 3 entities in 1 person contrary to the separation of each entity having their own function and identity. If you look at the constitution these are passages literally opposite to the biblical kingship foundation as it is a Babylonian setting. However, the laws that govern MEN are a different beast on their own. Its fundamental Commercial code, which we have already describe to be the same as the Maritime law or the UCC code, directly derives from the bible:

1. Under the Laws of Commerce, Truth is Sovereign

The foundation of the Uniform Commercial Code (U.C.C.) is Commercial Law. The foundation of Commercial Law is based upon certain universal, eternally just, valid, moral precepts and truths. The basis of Commercial Law is the Law of Exodus (i.e. The 10 Commandments) of the Old Testament and Judaic (Mosaic) Orthodox Hebrew Commercial law. The Laws of Commerce have remained unchanged for at least six thousand years and form the basis of western civilization, if not all nations. This law of commerce therefore applies universally throughout the world. Real Commercial Law is non-judicial and is prior and superior to, the basis of, and cannot be set aside or overruled by the statutes of any government, legislature, governmental or quasi-governmental agencies, courts, judges, and law enforcement agencies, which are under an inherent obligation to uphold said Commercial Law. Commercial Law is a "War of Truth" expressed in the form of an intellectual weapon called an Affidavit. An Affidavit is merely a written list of facts or truths signed under penalty of perjury and usually notarized. The person composing and signing an affidavit is called the "affiant". It is "survival of the fittest" where the last unrebutted stands triumphant.

In the Laws of Commerce, the eternal and unchanging principle of the law are:

1. A workman is worthy of his hire. Authorities: Exodus 20:15; Lev. 19:13; Matt. 10:10; Luke 10:7; II Tim. 2:6. Legal maxim: "It is against equity for freemen not to have the free disposal of their own property.

2. All are equal under the law (God's Law-Moral and Natural Law). Authorities: Exodus 21:23-25; Lev. 24:17-21; Deut. 1:17, 19:21; Matt. 22:36-40; Luke 10:17; Col. 3:25. Legal maxims: "No one is above the law."; "Commerce, by the law of nations, ought to be common, and not to be converted into a monopoly and the private gain of a few."

3. In commerce, truth is sovereign. See Exodus 20:16; Psalm 117:2; John 8:32; II Cor. 13:8. Legal maxim: "To lie is to go against the mind." Oriental proverb: "Of all that is good, sublimity is supreme."

4. *Truth is expressed in the form of an Affidavit. See Lev. 5:4-5; Lev. 6:3-5; Lev. 19:11-13; Num. 30:2; Matt. 5:33; James 5:12.*

5. *A matter must be expressed to be resolved. See Heb. 4:16; Phil. 4:5; Eph. 6:19-21. Legal maxim: "He who fails to assert his rights has none."*

6. *An un rebutted affidavit stands as truth in commerce. See 1 Pet. 1:25; Heb. 6:13-15. Legal maxim: "He who does not deny, admits."*

This is the basis of public law VS Private laws. Remember that the private laws that drive the commercial understanding of men supersede all other laws. However, your Status cannot be under the District of Columbia Jurisdiction. This is where the term Sovereign and rights clashes. According to the Bar Association no one should deviate from its bind, if one tries then one should be labeled as an anti-government. However, understanding and knowledge, which helps from past mistakes should give you the incentive to own your name, rights and future ei: wealth.

IMMUNITY LAW

These laws refer to the authority of the creator given to men. These laws gave birth to statues with their own jurisdiction, where all RIGHT belonging to oneself has been acknowledged, filed and maintained forever. CESTUI QUE VIE TRUST (HE WHO LIVES)

London **1666**, during the black plague and great fires of London, Parliament enacted an **act** behind closed doors, called **Cestui Que Vie Act 1666**. The **act** being debated was to subrogate the rights of men and women, meaning all men and women were declared dead, lost at sea/beyond the sea.

REBUTTABLE PRESUMPTION¹⁹

Conspiracy theorist on the "Cestui Que Vie Act 1666" implies that state ownership of their body applies via the birth registration process, and unless this presumption is lawfully refuted before the time period of seven years elapses after registration, they become the property of the state, having been declared legally dead, or "lost at sea".

This is quite a fantastical proposition, based on abstract speculation regarding the intention of the 1666 Act. It is the foundation for the version of "Maritime Admiralty Law" which is the jurisdictional reason for the enforceability of statute law.

At that particular time in history, many English people were “over the seas” mainly involved in the Anglo-Dutch wars. The common tale offered is: When the United States went off the gold standard in 1933, the federal government somehow went bankrupt. CONSIDERATION: THE INTERESTS OF YOUR FAMILY AND THE COMMUNITY, DRIVEN BY MORAL UNDERSTANDING AND VALUES.

3. INTEREST DYNAMICS

ANALYSIS: INTEREST AS A VALUE MULTIPLIER, INFLUENCED BY THE EFFORT, STRENGTH, AND CONSISTENCY OF THE INVESTOR. THE CURRENT TREND LEANS TOWARDS A ONE-SIDED SETTING WHERE EVERYONE ASSUMES A DEBTOR ROLE, IMPACTING THE MULTIPLIER BASED ON REPAYMENT. WHAT WOULD THE SCENARIO BE IF YOU WERE THE CREDITOR?

CONS TO UNDERSTAND:

1. FIAT MONEY OR CRYPTOCURRENCY IMPACT

OBSERVATION: BOTH FIAT MONEY AND CRYPTOCURRENCY CONTRIBUTE TO SOCIETAL DIVISIONS IN TERMS OF CLASSES, EDUCATION, CONTROL ABILITIES, AND RESOURCES. ADDITIONALLY, THEY HAVE THE POTENTIAL TO ERODE MORAL VALUES, COMPELLING INDIVIDUALS TO COMPROMISE THEIR INTEGRITY FOR THE PURSUIT OF A DREAM. A REFERENCE IS MADE TO THE GENESIS BOOK, HIGHLIGHTING THE SERPENT'S PROMISE TO WOMEN.

2. MANIPULATION OF BENEFITS:

INSIGHT: BENEFITS BECOME A RESPONSE DERIVED FROM DIRECT INVESTMENT, SHAPED BY THE INTEREST OR THE PERCEIVED OUTCOME DESERVING OF THE INVESTOR. EDUCATION FROM SOURCES LIKE TV AND THE PREVAILING SYSTEM INFLUENCES THE EMPOWERMENT OF PRODUCTS, INCLUDING ONE'S POTENTIAL INVESTMENT.

WHAT IS SOVEREIGNTY

It is the supreme power of authority that is self-govern with the authority. In most countries people are presumed sovereign if your country is, however most people are not sovereign due to the lack of knowledge of the system they reside in and its origination. It usually requires ample knowledge of the law to keep your rights under a sovereign nation.

In the country of Haiti, according to the Supreme Haitian Court all Haitian are sovereign however the country's Commerce is not.

Awaken definition of Sovereignty:

It is the ability to have and retain supreme power over self, goods and family, through knowledge, caring and moral compass under GOD. Sovereignty also reflects the laws that govern its system to benefit its people commercially and internationally without jeopardizing its wealth or health of others.

CONTRACTS TO TREATIES

Treaties are the principal source of Public **International Law**... An agreement between two or more States will not be a **treaty** unless those countries intend the document to be binding under an **international law**. **Treaties** can be bilateral (between two States) or multilateral (between three or more States)²¹.

There are **two types** of **treaties**, lawmaking **treaties** and contractual **treaties** or multilateral **treaties** **which** are agreements made by **three** or more countries. According to Slomanson²², lawmaking **treaties** are **treaties** that set up a new rule in **international law**.

This for example would include the **Law** of the Sea treaty, the Antarctic Treaty or the Chemical Weapons Convention.

Three powers- Financial, Religious & Army

The international laws fall under the fundamental belief of the One World Government which can enforce contractual treaties or approved world concerns and decisions. This power is situated at the United Nations. Meanwhile sanctions would be taken through Commercial laws, which is inextricable from the Maritime Laws ruled by the Pope. The Rothschild controls all Central Banks worldwide. Their headquarters is in the City of London ie.:(World Bank, IMF ect...). However, when all is said and done the only drivers are the spiritual drivers who control the people's perception and mind. The Pope in the Vatican Country rules this power.

Common denominators:

1. All these locations are set legally as countries within a country.

TRUST, TRUSTEE AND BENEFICIARY

What is a Trust?

A Trust is an entity created to hold assets for the benefit of certain persons or entities, with a trustee managing the **Trust** (and often holding title on behalf of the **trust**). ...

There are also court-decreed "constructive" and "resulting" **trusts** over property held by someone for its owner.

The **trust** must be set up as either revocable or an irrevocable **trust** funded while you are still alive. Its **main purpose** is to protect the beneficiary from outside forces or inner enemy. The goal and law dictated the outcome of investment or the project beneficiary.

A living Trust is designed to allow for the easy transfer of the trust creator or settlor's assets while bypassing the often complex and expensive legal process of probate. Living trust agreements designate a trustee who holds legal possession of assets and property that flow into the trust.

Understanding and having knowledge of the system allows you to see the true face of this beast that was put in place. The lack of its knowledge causes people to be victims.
